- 1. I hereby certify that all the particulars furnished by me are correct and also agree that admission may be granted on the terms, conditions and rules of the College. I understand that the admission shall be cancelled and fee paid by me will be forfeited if any of the particulars given by me at the time of admission or later are found to be incorrect or false or if found any incriminating particulars are concealed willfully.
- 2. I agree that the Principal's decision in all matters concerning my admission, studies, discipline and conduct will be final and binding upon me.
- 3. I understand that any association, active or passive, with any unlawful organization/union etc. is forbidden and I shall not have any ground to object if I am expelled or rusticated from the college due to my participation in any union/unlawful activity or any other activity which violates the code of conduct of the college.
- 4. I understand that consumption of alcohol, drugs or any other intoxicant within the College/Hostel premises is forbidden.
- 5. I am aware that as per Hon'ble Supreme Court orders, ragging in any form whatsoever is totally banned and criminal proceedings will be lodged in case I am found involved in instances of ragging. I understand that this will result in my rustication from the college and I will not be able to take admission anywhere in India.
- 6. I hereby declare that I have never been involved in or punished for any case of indiscipline during my school or college career. There is no inquiry pending against me with the school/college/police/other authorities of the state to which I belong or any other state where I resided at any time.
- 7. I am aware that I should be regular and punctual in attending classes and Shortage of Attendance below 75% in aggregate of all the subjects shall in No case be tolerated.
- 8. I understood that Students should neither leave the classrooms nor the campus without the prior permission of the Principal / HOD/ Class Counsellor during working hours.
- 9. I confirm that I have submitted the original certificates to the college on my own will and they shall be returned to me after the same are verified by the college. I will abide by the norms of the college and clear my dues.

- 10. I agree that if any component of fee is revised by the competent authority, the enhanced amount if any shall be deposited within two weeks of issue of such notification. I understand that the fee has to be paid in advance before each semester.
- 11. FORM - IV HOSTEL RULES & REGULATIONS

(Please read carefully before signing)

- 1. Ragging is strictly prohibited in any form; if anybody found guilty, severe action will be taken.
- 2. Students are prohibited from consuming alcohol, narcotic drugs or any intoxicating substance in the hostel premises.
- 3. All visitors to the hostel including parents/guardian will have to make necessary entries in the visitors book available at the hostel entrance with the security guard.
- 4. Students should not keep any unauthorized property and unauthorized guests in his/her room.
- 5. No person, either guest or otherwise shall be permitted to stay overnight in any part of the hostel. In case, guest want to stay overnight in the hostel, he/she shall take permission from principal.
- 6. All students are expected to be back in the hostel by 6.00 PM, if any student wishes to be away, he/she should take permission from the hostel authority showing appropriate reasons.
- 7. Students are responsible for the safekeeping of their valuables. Students should arrange their own locks and should take proper care of their belongings.
- 8. Students are not allowed to organize any group/religious activities in their room.
- 9. Students should handle hostel equipment, furniture, mess property with care and not abuse or tamper with it. in case of contrary behaviour applicable, fine will be charged by the hostel management.
- 10. Students have to use water and electricity judiciously. If any electrical appliances like fan, tube, etc., are found Switched ON in the absence of students at their rooms, fine of Rs.1000/- Day will be charged by hostel authorities.
- 11. Garbage and wastage should only be put at garbage box available nearby in the hostel premises.
- 12. Students during their stay in the hostel will be governed by rules framed by the hostel management.
- 13. Students will not enter rooms of other students without permission of the inmates.
- 14. Every case of illness and accident must be reported immediately to the hostel authorities.
- 15. No function or celebration shall be organized at hostel premises except with the permission of the Principal.
- 16. Allotment of room furniture etc. will be entirely at the discretion of the Warden and no complaint in this regard will be entertained.
- 17. Any complaint from the neighbours /society against students will result in strict action.
- 18. Hostel accommodation (room) can be changed by the management if found necessary at any point of time.
- 19. Students indulging in use of abusive and threatening language, physical fights, use of force to get any unfair act accomplished, etc. will be punished. Further, they are liable to be expelled from the hostel/Institute immediately.
